<u>The purpose of the grant</u>: The Commissioner may make Crime and Disorder grants to any person or organisation. These are grants which, in the opinion of the Commissioner, will secure, or contribute to securing, crime and disorder reduction in Sussex.

The 'Safer in Sussex' Community Safety Fund (CSF) and money recovered from the Proceeds of Crime Act (POCA) Fund both provide financial support to local projects that tackle crime and improve community safety.

<u>Conditions attached the grant:</u> Each application was assessed against the Fund criteria and the ability of the project to actively and directly address the priorities in the Commissioner's Police & Crime Plan. The Terms and Conditions of the grant are set out on the funding application form.

The reasons why the Commissioner considered that the grant would secure, or contribute to securing, crime and disorder reduction in Sussex, where appropriate: The Commissioner supported local projects that demonstrated how they would contribute to her priorities in the Police & Crime Plan and will monitor their outcome.
